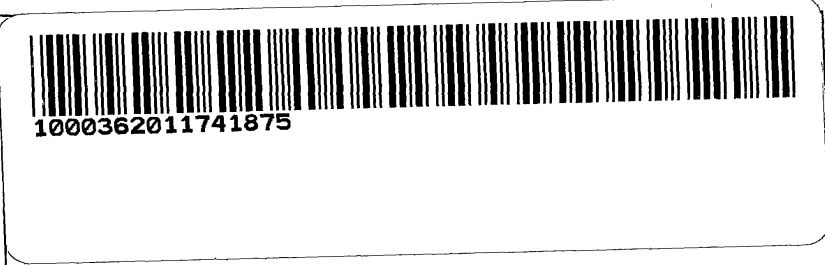


Mr **Richard Tangu** will replace Mr Festus Ndeh as Foundation Director

Mr **Blaise Che** will fill the role of Assistant Treasurer & Comptroller of the Foundation


Ms. **Victorine Yangni** will hence Financial Treasurer and Deputy Comptroller at the Foundation

In her new role and position, they each would enjoy all the rights and privileges permitted by the bylaws of the Foundation.


