**RE: REPORT OF POSSIBLE TERRORISM AND TERRORIST IN YOUR JURISDICTION ENGAGED BY CHRISTOPHER ANU FOBENEH A.K.A. CHRIS ANU, AND REQUEST FOR AN INVESTIGATION.**

Date of Incident: October 2016 to present.

Dear Mr. Shaw:

We present to you a matter involving U.S. national security, terrorism, and violent crimes. The United States is **not** a safe harbor for natives of foreign countries, such as the person reported CHRIS ANU, to engage in public leadership of armed terrorist groups, material support of terrorism, international terrorism, aiding and abetting in a long list of federal crimes, accessories to crimes before and after the fact, from his residence at 495 Hall St., Manchester, NH 03103 (within your jurisdiction). The action and conduct of CHRIS ANU, from his residence at Hall street, Manchester, poses an existential threat to tens of thousands of US citizens of Cameroon origin, and US citizens generally. A terrorist harboring in our midst is a most dangerous proposition, and such a possible scenario must be investigated comprehensively.

On information and belief, MR. CHRIS ANU is in violation of virtually all laws against international terrorism, violence, murder, kidnappings, arson, and other most vile criminal acts. Mr. Anu, along with all those residing in the USA who act



in agency, joint venture, conspiracy, with him must be investigated and brought to justice.

With the foregoing in mind, on behalf of certain victims, U.S. citizens and residents of Cameroon origin, whose parents, siblings, children have been killed, maimed, tortured, body parts cut with a machete, property burnt, and for others, their children prevented from going to school for the past two years, we hereby submit this request to have **CHRIS ANU** thoroughly investigated because he is, upon information and belief, committing multiple terrorism and other federal crimes from his residence at Hall St., Manchester, NH, listed below:

### **A. VIOLATIONS**

On information and belief, Mr. Anu has committed the following violations, without limitation:

1. “International terrorism,” according to 18 U.S.C. § 2331 is defined as “activities that involve acts or acts dangerous to human life that are in violation of the criminal laws of the United States or of any State, that would be a criminal violation if committed within the jurisdiction of the United States or of any State.”
2. 18 U.S.C. §2(a) — Aiding, abetting, counseling, commanding, inducing or procuring a federal crime;
3. 18 U.S.C. §371 — Conspiring to commit a federal crime;
4. 18 U.S.C. §2332b — Conspiring to commit an act of terrorism;
5. 18 U.S.C. §2339A - Providing material support to terrorists;
6. 18 U.S.C. §2339C - Prohibitions against the financing of terrorism;
7. CA Penal Code §31 — Accomplice liability – Aiding and Abetting Law;
8. CA Penal Code §182 - Criminal Conspiracy ( to crimes of murder, kidnappings, arson, assault, battery, without limitation )
9. CA Penal Code §32 – Accessory after the fact ( to crimes of murder, kidnappings, arson, assault, battery, without limitation )
10. Other crimes, including accessory before the fact, murder, kidnapping, arson, robbery, assault and battery, and seeking the overthrow of a foreign government through the use of force and war in violation of 18 U.S.C. §2385.

### **B. FACTS ESTABLISHING PROBABLE CAUSE**

We have compiled a file comprising 344 social media and other publications from Mr. Anu evidencing his material support (as defined by the Supreme Court of the United States, “material support” means providing “training”, “expert advice or assistance”, “service” or “personnel” to armed organizations ) of terrorism that harms parents, siblings, children and other families of US citizens of Cameroon origin. Mr. Chris Anu, as evidenced in these posts and videos, provides “expert advise” “service” “training” and “personnel” to the armed militias and groups on how to intimidate civilians into submission, carry out killings, terrorize innocent civilians in hotels and students, burn down houses of those who do not cooperate and other atrocities. The post and videos are indisputable evidence, with Mr. Chris Anu personally acknowledging his criminal actions and accomplishment, and giving direct orders to his armed fighters and followers to kill, torture, maim, and burn the property of any civilians that don’t subscribe to his political goals. **Please contact our office for a copy of this evidence compiled against Mr. Anu.**

The brutal actions and atrocities committed by the armed terrorist groups led by Mr. Anu are well documented by credible news organizations such as the BBC, RFI, Reuters, Amnesty International.

Additional specific material support of crimes, terrorism, and aiding and abetting in a long laundry list of federal crimes which, upon information and belief, are committed by Mr. Chris Anu include:

1. Fund raising for the armed militia organizations whose official conduct and policies are all crimes under USA laws
2. Using his facebook posts to provide instructions on strategy, policy, and armed militia regulations that have killed hundreds of civilians
3. Recruiting of fighters who have killed hundreds of innocent civilians
4. Assistance with procuring and providing weapons, equipment, and other tangible materials that kill innocent civilians
5. Coordination with other separatists groups abroad and in Cameroon
6. Leadership of the Ambazonia Interim Government which is a rogue government domiciled in the USA
7. Expert advise and assistance on how to obtain separation by violence and force and war from Cameroon
8. Assistance with the training of armed fighters

9. Using other social media such as email, twitter, skype, whatsapp to promote a violent agenda, plan the dates and times of attacks, and other activities in violation of USA laws.
10. Intimidation, threats, and killings of anyone who opposes their goal of secession; and so on and forth.
11. Formation of an illegal "government" called Ambazonia, with offices in the USA, and engaging in the collection of "taxes" for his government from within the continental USA, in violation of State Department laws and regulations, and USC codes on foreign governments activity and operational rights within the USA.

In fact, on multiple occasions in September, October and November, 2018, Mr. Anu materially supported the commission of massacres against the U.N. personnel unless they provide "peace keeping forces." On information and belief, his message constituted a material support and incitement which led to his armed militia killing American Charles Wesco, brother of Indiana State Representative Timothy Wesco, on October 30, 2018.

In a Press release dated November 14, 2018, Mr. Anu declared any lawyers who participated in Cameroon Bar Association elections to have acted in "betrayal" and "treason" against his Government of Ambazonia. Consequently, several Cameroonian lawyers, including this writer, received death threats, while others were reportedly beaten by his armed militia.

Critically, against all US laws on education for children, and in particular laws on compulsory education for kids, Mr. Anu and his government, through their material support of violence and terror and in publicly seeking to make Cameroon "ungovernable", have prevented children in the North West and South West regions from going to school for over two years. Students that disobey have had their hands cut with knives, raped, or beaten to near death. In veiled threats to discourage parents from sending their children to school, Mr. Anu's press release tells parents "your children go to school at your own risk."

On May 8<sup>th</sup>, 2018, Mr. Anu wrote a post indicating that all landlords should terminate the leases of "colonial administrators of French Cameroun." In the last week of June 2018, as well as July through present, acting in furtherance of Mr.

Anu's edict, and due to the material support provided by Mr. Anu, several family members whom I represent were killed, beaten, and their cars and property burnt.

In a press release dated March 22, 2018, Mr. Anu instructed his armed supporters to threaten, intimidate, and terrorize "every wanna be Senators and Councilors who want to vote." Due to this incitement, participation, and material support of violence and terror through this press release, innocent citizens who sought to vote during elections were killed, tortured, kidnapped, mutilated, and their properties burnt, including many of our clients.

In an article entitled "Disagreeing to Agree", dated March 12, 2018, attached as an exhibit, Mr. Anu declared "I have said that hit and run kidnappings are good strategies as far as the targets are certain institutions and very high profile individuals like SDOs and some of these recalcitrant politicians." He goes on, "And you know where hit and run can be most effective too? Of course, LRCC territory and their economic interests." Acting on this incitement, material support, and participation, Mr. Anu's armed militia have now engaged in systematic kidnappings of individuals and politicians, as well as killings and attempted assassinations. The families we represent lost their husbands, wives, children, and property, due to his material support of his armed local militia, that execute his instructions spelled out in his press releases and writings.

**We have saved all the evidence of his aiding and abetting/accessory to crimes before and after the fact, criminal conspiracy, in violent crimes and terrorism, including material support of terrorism, noted above, and will provide it to your office upon request.**

## **C. SUFFERINGS OF THOUSANDS OF US CITIZENS OF CAMEROON ORIGIN BECAUSE OF THE ACTIONS OF MR. CHRIS ANU AND ARMED MILITIA**

According to most reputable organizations such as Amnesty International, Human Rights Watch, or the International Crisis Groups, it is estimated as of December 2017 that the conflict in Cameroon – which we report as being directly caused, incited, participated, materially supported by the actions of Mr. Chris Anu and his armed militia groups, acting in a joint venture, aiding and abetting each other, acting in agency - has resulted in 500 civilians who have died in the violence, and the United Nations counts 30,000 Cameroon Anglophone refugees in Nigeria and

437,000 internally displaced in Cameroon. An incredible half a million Cameroonians are suffering a life of abject misery, poverty, and nastiness, away from their homes, due to the actions and conduct of Mr. Chris Anu, and his armed militia and related organizations.

The United States citizens victims we represent, as well as thousands of US citizens of Cameroon origin residing in the USA, wake up each morning, checking their phones, their whatsapp messages, and fearing the worst, always likely to happen: families and friends kidnapped for ransom, silenced into submission with threats on their persons and lives, killings of family members, and other atrocities. Without the material support Mr. Chris Anu provides to the armed militia, and readily admits about it on his social media platform (see exhibits attached), resulting in the verifiable massacres noted and documented by reputable organizations such as Amnesty International, US citizens of Cameroon origin would not have this daily anguish, pain, and feeling terrorized and helpless. USA businesses have lost, reportedly, tens of millions of dollars invested because of Mr. Anu's actions and material support of international terrorism.

It is against this backdrop that **we humbly request an investigation into the actions and conduct of Mr. Chris Anu ( full real name is: CHRIDTOPHER ANU FOBENEH) which we believe constitutes material support of terrorism, as well as a long laundry list of immigration and federal crimes**, partially listed above, which he commits from his residence in Manchester, NH, and causing unimaginable pain to thousands of US citizens of Cameroon origin, as well as anguish and sufferings to millions of Cameroonians.

We thank you in advance for your anticipated professional courtesy and cooperation.
